## Your Privacy Matters

Medtronic's mission is to contribute to human welfare by the application of biomedical engineering in the research, design, manufacture, and sale of instruments or appliances that alleviate pain, restore health, and extend life. Central to this mission is our commitment to be transparent about Personal Data Medtronic collects, how it is used, processed and with whom it is shared.

Medtronic MiniMed Inc. and Medtronic affiliated companies offer diabetes therapy management solutions, which consist of a range of medical devices (including insulin pumps, continuous glucose monitor and Smart insulin Pen), device management software (including CareLink™ Personal), associated mobile applications and associated services (including logbooks, product support and education), that are all part of the Medtronic Diabetes integrated ecosystem operated by or on behalf of Medtronic ("Medtronic Diabetes Management Solutions" or "Solutions").

This Privacy Statement applies to the Personal Data (including Patient Health Data) of Users processed in CareLink™ Personal, related applications and other Medtronic Diabetes Management Solutions that are connected to the CareLink™ Personal account. CareLink™ Personal is a web-based software designed to help take information that is uploaded to CareLink™ Personal from other Medtronic Diabetes Management Solutions and organize it into easy-to-read charts, graphs and tables. These reports can help Patients, Legal Guardians, Care Partners and Health Care Providers discover trends and other information that can lead to improved therapy management for greater control. In this Privacy Statement is described what Personal Data of Users is collected, how these Personal Data are processed, how long Personal Data are retained, with whom Personal Data is shared, which rights

<b>1. Introduction</b>	<p>- <i>Definitions</i></p> <p><b>“associated mobile applications”</b> means all mobile applications that require registering for CareLink™ Personal. Please check the End User License Agreement of a Medtronic mobile application to find out if it is an associated mobile application within the meaning of this Privacy Statement.</p> <p><b>“Care Partner”</b> means any individual that has been granted access by a Patient to view a secondary display with the Patient’s diabetes information in CareLink™ Personal.</p> <p><b>“Controller”</b> means the natural or legal person, public authority, agency or other body which, alone or jointly with others, determines the purposes and means of the processing of Personal Data.</p> <p><b>“Health Care Provider”</b> means a medical professional, such as a doctor or nurse, that provides medical advice and services to individuals under their care (e.g., their patients).</p> <p><b>“Health Data”</b> means different types of health related data generated and measured through the Medtronic Diabetes Management Solutions that are uploaded to CareLink™ Personal or CareLink™ Clinic.</p> <p><b>“Legal Guardian”</b> means any individual who registers on CareLink™ Personal on behalf of a Patient who is under 18 years of age and under their guardianship.</p> <p><b>“Medical Center”</b> means a hospital, clinic, or other health care institution where health and/or medical advice and services are provided to individuals such as Patients.</p> <p><b>“Patient”</b> means any individual who uses CareLink™ Personal for their diabetes management.</p> <p><b>“Personal Data”</b> means all the information which relates to an identified/identifiable natural person. This means that any information that can lead to knowing who you are (either directly or indirectly) is qualified as ‘Personal Data’.</p>

	<p><b>“Users”</b> means Patients, Legal Guardians, Care Partners and Health Care Providers who use Carelink™ Personal.</p> <p>- <i>What is CareLink™ Personal and what purpose does the software serve?</i></p> <p>CareLink™ Personal is a web-based software designed to help take information that is uploaded to CareLink™ Personal from Medtronic Diabetes Management Solutions and organize it into easy-to-read charts, graphs and tables. These reports can help Patients, Legal Guardians, Care Partners and Health Care Providers discover trends and other information that can lead to improved therapy management for greater control.</p> <p>CareLink™ Personal is a TFDA marked Class II medical device in Taiwan.</p> <p>- <i>Connection to the CareLink™ Clinic Software</i></p> <p>Establishing a link to CareLink™ Personal will enable the Medical Center to view their Patients’ Health Data from Medtronic Diabetes Management Solutions as uploaded in CareLink™ Personal (e.g. blood glucose levels, log book entries) in CareLink™ Clinic. CareLink™ Clinic is used by Medical Centers and Health Care Providers to inform therapy decisions and to improve engagement.</p> <p>When a link is established between Carelink™ Personal and CareLink™ Clinic, due to the bi-directional exchange of data between these systems, Patients will also have direct access in Carelink™ Personal to their device data as originally uploaded in CareLink™ Clinic.</p> <p>In order to establish the link, an explicit consent is built into CareLink™ Clinic to which a Patient needs to agree in addition to performing a one-time confidential entering of their unique username and password. A Patient can decide to delink his Carelink™ Personal account from CareLink™ Clinic at any time in the settings of their CareLink™ Personal account which will stop any further sharing of their future CareLink™ Personal Data with that CareLink™ Clinic account.</p> <p>Please note that when a Patient consents to establish a link between Carelink™ Personal and CareLink™ Clinic, the following categories of Personal Data are exchanged and processed for all the purposes to which the Patient has consented in CareLink™ Personal:</p> <p>- <b>Health Data:</b> Different types of Health Data generated and measured through Medtronic Diabetes Management Solutions</p>

<b>2. What Personal Data does Medtronic collect and use?</b>	<p>Medtronic collects, processes, stores and uses Personal Data (including Patient Health Data) of Users that they provide directly into CareLink™ Personal or related CareLink™ apps or that is generated through the use of CareLink™ Personal and other Medtronic Diabetes Management Solutions. The following types of Personal Data are processed through CareLink™ Personal and related CareLink™ apps:</p> <p><b>Patients</b></p> <ul style="list-style-type: none"> <li>- <b>Contact and account details:</b> Name, phone number, email address, home address, country/region of residence, username, password, security question and answer;</li> <li>- <b>Demographic data:</b> Age category and gender;</li> <li>- <b>Technical Device Data:</b> Type of connected device and its serial number; historical usage data;</li> <li>- <b>Health Data:</b> Different types of Health Data generated and collected through Medtronic Diabetes Management Solutions (e.g. glucose values, insulin values, physical exercise, information on meals consumed, carbohydrates intake).</li> </ul> <p><b>Legal Guardians and Care Partners</b></p> <ul style="list-style-type: none"> <li>- <b>Contact and account details:</b> name, email address, username, password and telephone number;</li> <li>- <b>Technical Device data:</b> Type of connected device and its serial number; historical usage data.</li> </ul> <p><b>Associated mobile applications</b></p> <p>The following types of Personal Data of Patients are processed through the associated mobile applications:</p> <ul style="list-style-type: none"> <li>- CareLink™ Personal login information (see above description of contact and account details);</li> <li>- Diabetes related Health Data (see above description of Health Data);</li> <li>- Physical exercise information;</li> <li>- Meal consumption information;</li> <li>- Any other information that Users decide to enter and record in the application and that is related to their diabetes management such as information on medication intake.</li> </ul> <p><b>Cookies on the associated mobile applications – Patients only</b></p> <p>The following types of Personal Data of Patients are collected and processed through Adobe Analytics cookies on associated mobile applications:</p> <ul style="list-style-type: none"> <li>- The pages Patients open and interact with after each launch of the mobile application;</li> </ul>

	<ul style="list-style-type: none"> <li>- Number of times Patients launch and use the mobile applications on a daily and monthly basis as well as the day and the hour the mobile applications are launched;</li> <li>- The session length of Patients' use each time they launch the mobile applications and the aggregated total session length;</li> <li>- Number of times the mobile application crashes;</li> <li>- Number of days since last use;</li> <li>- The operating system version of Patients' device and device name.</li> </ul> <p><b>Analytics tools used with associated mobile applications</b></p> <p>Analytics tools such as Google Analytics for Firebase are used by Medtronic in relation to the Care Partner's CareLink™ Personal application to collect information about the use of the mobile application to improve the user experience.</p> <p>The types of information collected includes:</p> <ul style="list-style-type: none"> <li>- Store from which the app was downloaded and installed</li> <li>- Version name (Android) or the Bundle version (iOS)</li> <li>- User's country/region of residence</li> <li>- Brand name of the user's mobile device (e.g., Motorola, LG, or Samsung)</li> <li>- Mobile device category (e.g., phone or tablet)</li> <li>- Mobile device model name (e.g., iPhone5s)</li> <li>- Time at which the user first opened the app</li> <li>- If app is opened for the first time within the last 7 days</li> <li>- If app is opened for the first time in more than 7 days ago</li> <li>- Version of the device operating system (OS) (e.g., 9.3.2)</li> </ul> <p>Google Analytics for Firebase is managed by Google LLC ("Google"), located at 1600 Amphitheatre Parkway, Mountain View, CA, 94043, United States. By providing your consent to the use of Google Analytics for Firebase, you give Medtronic permission to collect information from your mobile device. Google Analytics will be enabled on the mobile application to collect information after you consent for collection of information. If you do not want Google Analytics for Firebase to collect information, you can choose not to provide your consent, or you can remove or take back your consent if you gave it previously.</p> <p>Please note that your consent is optional, and you are under no obligation to provide it. If you would like to stop the collection of your information through Google Analytics for Firebase, you can at any time change your consent preference by logging into your CareLink Personal account, go to settings, and select the consent function. If you remove or take back your consent, Google Analytics will stop collect any further data from that time moving forward.</p>

<b>3. Who is responsible for data processing?</b>	<p>The Medtronic entity that you can consider as your local data Controller (hereafter “Medtronic”) depends on the country/region where you reside. Please review our ‘List of Local Entities’ in Appendix A for the name and contact details of your local Medtronic entity as well as the list of recipients and their roles as listed in chapter 7.</p>
<b>4. For what purposes does Medtronic process Personal Data of Users?</b>	<p>Medtronic processes, uses and discloses Personal Data of Users obtained through CareLink™ Personal for the purposes listed below. For each purpose, for compliance with the requirements of applicable law, the legal basis to process Personal Data is specified as well as the legal ground that allows for the processing of Health Data where this is the case.</p> <p>Medtronic will indicate to you whether the collection, use and processing of your Personal Data is voluntary or mandatory. If you do not provide complete and accurate Personal Data which are mandatory, there may be potentially serious consequences for you and, depending on the circumstances, you may not be able to use or access the CareLink™ Personal app, system or related apps.</p> <p><i>a) Processing for the provision of services</i></p> <p>CareLink™ Personal is designed to process Health Data of Patients from compatible devices and provide Users with insights in the form of reports.</p> <p>Medtronic also processes Personal Data (including Patient Health Data) of Users to:</p> <ul style="list-style-type: none"> <li>• Provide Users with customer and product support such as technical and operational support to help Users resolve problems, issues or questions regarding CareLink™ Personal or other Medtronic Diabetes Management Solutions;</li> <li>• Provide Users with communications of an operational nature such as planned outages, software updates and maintenance of the product;</li> <li>• Monitor and diagnose technical issues which can limit the functionalities or working of CareLink™ Personal;</li> <li>• Monitor the safety and reliability of the Carelink™ Personal services and their underlying systems and software.</li> </ul> <p>Medtronic is required to obtain the explicit consent of Patients to process their Personal Data (including Health Data) for this purpose. Patients are under no obligation to provide their consent. However, as this is related to the primary function of CareLink™ Personal, Medtronic cannot provide Carelink™ Personal or the associated mobile applications to Users without the explicit consent of Patients. If Patients do not provide their consent, however, they are still able to use their device (e.g. insulin pump with continuous glucose</p>

	<p>monitoring, blood glucose meter, etc.) with exception of the Guardian™ Connect Continuous Glucose Monitor.</p> <p>Medtronic uses SMS text messaging to send Patients urgent (non-marketing) communications of an operational nature (e.g. planned outages or updates) that may be of benefit to them about CareLink™ Personal. Medtronic asks the explicit consent of Patients to contact them through SMS text messaging for this purpose. In case Patients do not consent to receiving SMS text messages containing urgent communications of an operational nature, they will receive this information through email.</p> <p>Medtronic also uses the SMS text message functionality as part of its Care Partner application through CareLink™ Personal to send SMS text message alerts. The Patient may decide to allow a Care Partner to receive SMS text messages. These SMS text messages enable the Care Partner to know when a Patient is about to or is currently experiencing a low or high blood glucose episode and status information about the Patient's devices. In case a Patient enables the SMS text message functionality for Care Partners, their Care Partners will receive SMS text messages that contain a Patient identifier that the Patient chooses and information about the specific alert that can contain Health Data (e.g. low sensor glucose or high sensor glucose). Please be aware that such SMS text messages, containing a Patient's Health Data, are transmitted to Care Partners without encryption and that they will be visible to third-party service providers who facilitate the SMS text messages as well as applicable wireless carriers. These third-party services providers may not comply with all data protection and security standards under your country/region's data protection laws. This service is optional and will only be provided when Patients and their selected Care Partners consent to the SMS text message functionality.</p> <p>Medtronic processes user engagement data of Patients through Adobe Analytics cookies on associated mobile applications to improve user experience. Medtronic also uses standard analytics reports through Google Analytics for Firebase to improve user experience of certain applications such as the CareLink™–Personal application. Medtronic asks the explicit consent of Patients and/or account owners to process their Personal Data (including Health Data) for this purpose.</p> <p>When cookies or the analytics tools are used, a Patient's consent is voluntary and that they will not be stopped or prevented from using the associated mobile applications if they decide not to provide consent.</p>

	<p><i>b) Processing necessary to comply with a legal obligation to which Medtronic is subject</i></p> <p>Medtronic processes Personal Data (including Patient Health Data) of Users to comply with its vigilance and post-market surveillance duties to ensure high standards of quality and safety of its medical devices as per applicable medical devices regulation. CareLink™ Personal software and associated products are medical devices whose operation may require monitoring under applicable regulations. If Medtronic detects potential abnormalities, the company is required by law in some jurisdictions to notify Users and/or regulatory authorities and to inform Users of any remedial action. Therefore, Medtronic processes Personal Data of Users to comply with a legal obligation. Health Data of Patients is processed for this purpose as it can be necessary to ensure high standards of medical devices. Where sufficient to meet the legal obligation, Medtronic pseudonymizes Personal Data, or creates and uses aggregated statistics calculated from Personal Data (including Health Data) of Patients. Aggregated data does not contain any information that can be used to directly identify Patients, but it does not completely exclude the possibility of identifying Patients. These statistics will be shared with regulatory bodies to obtain regulatory approval for products and services.</p> <p>Medtronic may be requested to process Personal Data (including Patient Health Data) of Users to comply with any reasonable request from competent law enforcement agents or representatives, governmental agencies or bodies, including competent data protection authorities, in which case the processing will be limited to what is minimally required to comply with the order.</p> <p><i>c) Processing for the establishment, exercise or defense of legal claims</i></p> <p>Medtronic processes Patient Health Data as necessary for the establishment, exercise or defense of legal claims or in the case where courts are acting in their judicial capacity. For the purposes of European law, the processing of Personal Data of Users for this purpose is based on the legitimate interests of Medtronic.</p> <p><i>d) Processing for the improvement and development of products and services and overall improvement of therapy management</i></p> <p>Medtronic intends to further research and to develop new products and services for Diabetes Management and improve existing products and services, investigate and document Patient outcome and device safety, as well as to improve therapy management and Patient treatment overall. For this purpose, Medtronic would like to create and use statistics calculated from Personal Data (including</p>

	<p>Health Data) of Patients in CareLink™ Personal and the associated mobile applications as well as the data coming from CareLink™ Clinic (in case Patients have linked their CareLink™ Personal account to CareLink™ Clinic in a hospital). Aggregated data does not contain any information that can be used to directly identify Patients, but it doesn't completely exclude the possibility of identifying Patients. These statistics will, among other things, be shared with regulatory bodies and help obtain funding for products and services.</p> <p>Medtronic asks the explicit consent of Patients to process their Personal Data (including Health Data) for this purpose. Please note that a Patient's consent is voluntary and that they will not be stopped or prevented from accessing CareLink™ Personal if they decide not to provide consent.</p> <p><i>e) Processing for the development of marketing materials</i></p> <p>Medtronic uses Personal Data (including Health Data) of Patients to develop marketing materials. These materials are used to demonstrate product performance and are presented at conferences and to Health Care Providers or enable Medtronic to improve training, education and support programs. Medtronic would like to create and use aggregated statistics calculated from your Personal Data (including Health Data) for this purpose. Aggregate data does not contain any information that can be used to directly identify you, but it doesn't completely exclude the possibility of identifying you.</p> <p>For this purpose, Medtronic asks the explicit consent of Patients to process their Personal Data (including Health Data) for this purpose. Please note that a Patient's consent is voluntary and that they will not be stopped or prevented from accessing CareLink™ Personal if they decide not to provide consent.</p> <p><i>f) Processing for direct marketing purposes</i></p> <p>To the extent allowed by your country/region's laws, Medtronic would like to process your Personal Data (including Health Data) such as your name, email and home address, diabetes type to send you marketing and promotional information about Medtronic and third-party products that can be used together with Medtronic's existing and future products. Additionally, Medtronic would like to contact you to conduct market research related to your use of our products. Medtronic intends to provide any such information or contact in writing (by regular mail, e-mail or fax).</p> <p>Medtronic asks the explicit consent of Patients for these direct marketing related purposes. Please note that a Patient's consent is voluntary and that they will not be stopped or prevented from accessing CareLink™ Personal if they decide not to provide consent.</p>

<p><b>5. Provisions for Legal Guardians and Care Partners</b></p>	<p><i>a) Processing of Personal Data of Legal Guardians and Care Partners</i></p> <p>The Personal Data of Legal Guardians and Care Partners is processed to allow them to access the CareLink™ Personal web site and associated mobile applications. Medtronic will process the name, email address, username, password of Legal Guardians and Care Partners for this purpose as it is necessary to enable them to use CareLink™ Personal.</p> <p>The Patient or Legal Guardian may choose to enable another feature which includes SMS text message functionality for Care Partners. In order to be able to send SMS text messages to Care Partners, Medtronic processes the Care Partner's name and telephone number. This processing is based on the Patients' consent as well as the Care Partner's consent.</p> <p><i>b) Parental consent</i></p> <p>Medtronic is under a legal obligation to obtain parental consent for underage Users of CareLink™ Personal and in this context is allowed to process Personal Data to verify the identity and role of Legal Guardians.</p> <p><i>c) Access to Care Partners</i></p> <p>A Patient or Legal Guardian can invite a Care Partner who can be a caregiver (e.g. a parent, other family member or friend) or a Health Care Provider to view their diabetes information on the CareLink™ Personal web site. When using compatible devices, the Patient can enable a secondary display of diabetes information for Care Partners.</p> <p>If a Health Care Provider uses CareLink™ Personal via Health Partner Share, the Health Care Provider will become the data Controller of the Personal Data he processes through the CareLink™ Personal web site.</p>
<p><b>6. How does Medtronic protect Personal Data of Users?</b></p>	<p>To protect Personal Data (including Patient Health Data) of Users, Medtronic maintains appropriate administrative, technical and organizational safeguards. The appropriate safeguards include individual user accounts to which access is only granted with a valid username and password, and two-factor authentication (if enabled). Personal Data is encrypted when it is transferred from the insulin pump to the CareLink™ Personal on the Patient's computer or laptop and then the Personal Data is encrypted again when it goes from the Patient's browser to the CareLink™ Personal server. The CareLink™ Personal server is continuously monitored for potential attacks or intrusions. Medtronic regularly reviews its policies and procedures, and the physical environment of its equipment to</p>

	<p>improve the technical and organizational measures taken in regard to security measures with the aim to protect Personal Data (including Patient Health Data) of Users against accidental, unlawful or unauthorized disclosure, alteration or destruction.</p>
<p><b>7. How does Medtronic share Personal Data of Users?</b></p>	<p>The Personal Data (including Patient Health Data) of Users collected and processed through CareLink™ Personal and other Medtronic Diabetes Management Solutions are securely processed in an ISO 27001 certified physical data center located in the Netherlands.</p> <p>Medtronic does not disclose Personal Data (including Patient Health Data) of Users except for the purposes described in this section of the Privacy Statement. Medtronic shares Personal Data (including Patient Health Data) of Users with our affiliates as described below.</p> <p>Medtronic will also share Personal Data (including Patient Health Data) of Users with third-party service providers who perform services for Medtronic; these third parties service providers all act as data processors which means that they will process Personal Data (including Patient Health Data) of Users on behalf of Medtronic and only do so based on documented instructions from Medtronic.</p> <p><i>a) Recipients associated with processing for the provision of services</i></p> <p><b>Medtronic MiniMed Inc.</b> based in 18000 Devonshire Street, Northridge, CA 91325, United States, is the legal manufacturer of CareLink™ Personal, the compatible devices and diabetes management tools – insulin pump, continuous glucose monitor, blood glucose meter(s), logbooks and associated mobile applications – and determines the processing of Personal Data (including Patient Health Data) of Users together with <b>Medtronic Hong Kong Medical Limited</b> based in Hong Kong.</p> <p><b>Medtronic MiniMed Inc.</b> will provide second-level and third-level technical and customer support if an issue cannot be resolved at first-level which is performed by local Medtronic support staff through regional hubs.</p> <p><b>Medtronic BV</b> with registered address at Industry Park, Earl Bakkenstraat 10, 6422 PJ, the Netherlands, is responsible for server installation and maintenance of the CareLink™ Personal servers in the data center located in the Netherlands.</p> <p><b>F. Hoffmann-La Roche Ltd</b> based in Grenzacherstrasse 124, CH-4070 Basel, Switzerland. F. Hoffmann-La Roche Ltd is the manufacturer of the blood glucose meters that collect blood glucose data. Medtronic shares business operational data that is aggregated (e.g. total</p>

Hoffmann-La Roche Ltd.</b></p> <p><i>b) Recipients associated with processing in accordance with legal requirements</i></p> <p><b>Medtronic MiniMed™ Inc.</b> is the legal manufacturer of CareLink™ Personal, the compatible devices and diabetes management tools (such as supported insulin pumps, continuous glucose monitor, logbooks, and associated mobile applications) within the meaning of the European Medical Directive, and starting from its entry into force, the Medical Device Regulation, as well as any member state-specific implementing regulation and applicable medical device regulations in other jurisdictions (hereafter referred to as ‘Medical device regulations’) and the addressee of the statutory provisions.</p> <p><b>Medtronic Hong Kong Medical Limited</b> has been appointed by <b>Medtronic MiniMed™ Inc.</b> as the importer in Macau. Local regulations impose certain vigilance and post marketing surveillance obligations on manufacturer, importer, legal representatives which imply the processing of Personal Data (including Patient Health Data) of Patients. Any processing of Personal Data to comply with a legal obligation will be done in compliance with the requirements as prescribed by the legal obligations.</p> <p><b>Medtronic Bakken Research Center BV</b> based in Endepolsdomein 5, 6229 GW Maastricht, Netherlands receives Personal Data (including Health Data) of Patients to provide support for regulatory filings/approvals.</p> <p>Legal requirements also oblige Medtronic to share Personal Data (including Health Data) of Patients with regulatory bodies or governmental agencies.</p> <p><i>c) Recipients associated with processing for the improvement and development of products and services</i></p> <p><b>Medtronic Bakken Research Center BV</b> receives Personal Data (including Health Data) of Patients in order to improve CareLink™ Personal, compatible devices and diabetes management tools – insulin pump, continuous glucose monitor, blood glucose meter(s), logbooks and associated mobile applications – or to develop new products and services for diabetes management.</p> <p><i>d) Recipients associated with processing for the development of marketing materials</i></p>

	<p><b>Medtronic International Trading sàrl</b> and <b>Medtronic MiniMed Inc.</b> develop marketing and promotional materials on the basis of aggregated statistics collected from Personal Data (including Health Data) of Patients.
